## VACCINATION INSTRUCTIONS CAN-AM CROWN RACES March 2, 2024

All dogs entered in the race shall have had <u>Rabies and DHPP</u> [distemper, hepatitis (adenovirus 2), parainfluenza, and parvovirus] vaccinations within the 36 months previous to the race and at least 21 days before the start of the race. Additionally, all dogs must have had a <u>leptospirosis</u> vaccination within the 12 months prior to the race and at least 21 days before the start of the race. Yearling dogs must have had a booster for DHLPP and Rabies given within one year of their puppy vaccination series.

All required vaccinations must be administered at least 21 days before the start of the race (i.e. before February 10, 2024).

Bordetella immunization is recommended.

<u>Proofs</u> of vaccinations must be included with this completed Vax Form (Uniform Canine Vaccination Record)!! Owners who vaccinate their own dogs shall submit purchase invoices as proof of vaccination within the prescribed time period.

It is not necessary to submit vaccination records at the same time as your entry forms. However, drivers who have not submitted acceptable vaccination records before February 10, 2024 shall offer vaccination proofs at the pre-race veterinary examination, pay the \$20 late processing fee, and be moved to the end of the examination schedule regardless of bib number.
